Zaire ebolavirus (EBOV) virus-like particle (VLP). Purified VLP consisting of a mixture of three viral proteins embedded in a lipid bilayer (envelop), but do not contain genetic material and are not infectious.

### 4 - First aid measures

<b>Eye contact</b>	In case of eye contact, flush with copious amounts of water for at least 15 minutes. Seek medical attention if irritation occurs.
<b>Skin contact</b>	In case of skin contact, flush with copious amounts of water and soap for at least 15 minutes. Remove contaminated clothing and shoes. Seek medical attention if necessary.
<b>Inhalation</b>	If inhaled, remove to fresh air. If not breathing give artificial respiration. If breathing is difficult, give oxygen. Seek medical attention if necessary.
